



### LigerBot Standards of Behavior

- Newton Schools policies on illegal substances apply to all team activities.
- The LigerBots adhere to the Massachusetts anti-hazing and anti-bullying laws and to NPS policies on hazing and bullying. NPS policies can be found on the NPS web page.
- Both students and parents must register on the team website and STIMS.
- Students must have permission slips on file to participate in carpools and events. Events during school hours may require additional teacher signatures.
- Parents should be aware that students on the team will be using power tools, wiring electrical components, and accessing the internet, and sometimes communicating with adults outside the Newton school community.
- Students may communicate with the team through a variety of means including email and an instant messaging service called Slack. Parents should know that the LigerBots use real names and email addresses in Slack. Information on Slack is not communicated outside the team. The privacy policy for Slack is located at the following URL: <https://slack.com/privacy-policy>. All team rules apply to Slack.

### Standards for students at team meetings and events

- If for any reason you have conflict with another student, mentor, or coach, go to a coach to help you resolve that issue.
- If you are causing a disruption or distraction in a meeting, you will be directed to a job. If you continue to disrupt/distract others in the same meeting, your hours will not count. The same policy applies to training sessions.
- If you need to leave a meeting before your assigned job is done, you must tell the person who assigned you that job and the adult assisting you before you can leave. You must leave with a parent or adult unless otherwise agreed upon.
- Communication is very important... that's what allows the team to run. everyone is expected to keep up with Slack messaging and email and to respond in a timely manner.
- When you are asked to do something which you don't think is the best course of action, or disagree with for any reason, you must offer a reasonable argument or reasoning behind why you do not think it should be done. Always be respectful.
- When going to a team event, you should be presentable and have good hygiene.
- Be respectful of people and property, both within and outside the team. This is especially important when wearing your LigerBots shirt as your behavior reflects on the whole team. Do not install software on school or team machines without coach approval.
- Be respectful of sponsors at all times.
- Use common sense around tools, robots, electricity, and moving vehicles. Always wear safety glasses and tie back long hair when around machine/power tools. Obey the directions of coaches/mentors/other adults. Wear seatbelts in cars.

If a student egregiously and/or repeatedly violates these standards, a coach will contact their parent to discuss the issues and continued involvement with the team.

Participant (and the Parent/Guardian of a Participant under 18 years of age) understands that participation in the Program will expose Participant to risks of injury including, without limitation, injury from: building, lifting, and using electrical/mechanical robots and robot components; using tools; other participants; dancing and other associated activities. Participant (and the Parent/Guardian of a Participant under 18 years of age) understands that *ingenuityNE* does not select, employ, supervise or otherwise exercise authority or control over the coaches, mentors, and other participants in the Program. Participant, if 18 years of age or older, acknowledges and agrees that he/she is primarily responsible for his/her safety. The Parent/Guardian of a Participant under 18 years of age acknowledges and agrees that the Parent/Guardian is primarily responsible for the Participant's safety and that the Parent/Guardian will monitor, as appropriate considering the age of the Participant and other factors, the Participant's participation in the Program.
